

Without state legislative action on a permanent funding solution, SEPTA is unable to maintain current service levels. Initial service cuts will go into effect late August 2025 with additional cuts going into effect January 2026.

How will the Funding Crisis Service Reduction Proposal impact schools and universities?

In order to close the structural operating budget deficit, SEPTA is forced to cut nearly half of its service, reducing service levels across the region and eliminating dozens of routes. Service cuts will be implemented in August 2025 and January 2026.

At least one bus or rail line that serves the following middle schools, high schools, colleges, and universities will be eliminated, in addition to a 20% reduction in frequency across most remaining routes. Additionally, all remaining Metro and Regional Rail lines will conclude service at 9:00PM.

This proposal impacts all SEPTA riders, including those who use SEPTA to get to school. Where available, alternative services are described below.
